### Document Submission Checklist


Please use this checklist to ensure your supporting documents meet CES requirements in order for us to issue the Educational Credential Assessment (ECA) to you. Your application requires both scanned copies of documents provided to CES within your online application (Part A) and your Official Academic Record sent to CES directly from your awarding institution (Part B).

Proof of name change</b></p> <ul style="list-style-type: none"> <li>○ Provide this document if your name on your ID appears differently on your academic documents</li> <li>○ Acceptable documents include: a marriage certificate, an official government name change document, or a sworn affidavit</li> <li>○ The document should show both your original and current name</li> <li>○ Scan both sides of the document</li> <li>○ Ensure all pages are clear and legible and that no information is cut off</li> <li>○ Accepted Formats and File Extensions: doc, docx, jpg, pdf, png</li> <li>○ File Size Maximum: 10240 KB</li> </ul>

Proof of Name Change Translation</b></p> <ul style="list-style-type: none"> <li>○ Name change documents not in English or French must be accompanied with official word-for-word translations</li> <li>○ Scan both sides of the document</li> <li>○ Ensure all pages are clear and legible and that no information is cut off</li> <li>○ Accepted Formats and File Extensions: doc, docx, jpg, pdf, png</li> <li>○ File Size Maximum: 10240 KB</li> </ul>

Academic record (your copy)</b></p> <ul style="list-style-type: none"> <li>○ This document identifies courses taken, credits and grades received for all years of study</li> <li>○ Example documents include: official/attested/verified academic record (transcripts, mark sheets, statement of results, <i>relevé de notes</i>)</li> <li>○ Scan both sides of the document</li> <li>○ Ensure all pages are clear and legible and that no information is cut off</li> <li>○ Accepted Formats and File Extensions: doc, docx, jpg, pdf, png</li> <li>○ File Size Maximum: 10240 KB</li> </ul>

Academic record translation.</b></p> <ul style="list-style-type: none"> <li>○ Academic record documents not in English or French must be accompanied with official word-for-word translations</li> <li>○ Scan both sides of the document</li> <li>○ Ensure all pages are clear and legible and that no information is cut off</li> <li>○ Accepted Formats and File Extensions: doc, docx, jpg, pdf, png</li> <li>○ File Size Maximum: 10240 KB</li> </ul>
